What You Get

By signing this Agreement, you are entitled to rent The Leading Hand software for use by your business on two or more computers.

We will provide the program on CD with a User Manual, plus support and updates for the duration of the Agreement. (Support is for up to six hours over a twelve month period whilst the Agreement is in force.)

The initial contract is for six months, with rent payable monthly, in advance, commencing from the date of this Agreement. Provided your rent is paid up, you will be sent an unlock code every three months to enable The Leading Hand to continue to operate for the next three months.

Notices

All notices from us to you and vice-a-versa will be by means of email or fax to our respective email and fax addresses stated in this Agreement

Your Responsibilities

You will sign an Agreement to rent the Leading Hand multi-user licence for a minimum of six months.

Your payment will be charged / deducted on a monthly basis on the same payment day of each month, as established in this Agreement. The amount payable per month must be available in your nominated Credit Card or Direct Debit account.

You must have a computer, cabled network and printer that will work with The Leading Hand.

Support

Support is by telephone, internet and fax. **Support is for The Leading Hand only.** Hardware and other software (eg: Windows) is not included. Program updates will usually be supplied over the Internet. To get timely and effective support, we encourage The User to have access to the Internet.

On-site support is available as a separate chargeable item.

Pricing

We envisage this as a long-term agreement and will use our best endeavours to limit rent increases in accordance with movements in the Consumer Price Index. However, we cannot guarantee this. Prior notice will be given of any rent variation.

Termination

The Leading Hand multi-user rental licence is enforceable for six months from the date of the beginning of this Agreement.

After that, to terminate this Agreement, The User must notify The Supplier in writing.

After the first six months, this Agreement will also deem to have been terminated when payment is not made by The User in accordance with this Agreement.

No further unlock codes will be provided and you will not be able to enter information (eg: invoices) into the system. You will, however, be able to view and print reports. Support for The Leading Hand will also cease.

Your payments will cease on the first day of the following month. The Leading Hand program always remains the property of AMPL Software Pty Ltd. The data (customer details etc.) is the property of the user.

This Agreement may be terminated at any time by either The User or The Supplier.
